## **SCHOLARSHIP GUIDELINES (2)**

The participants are required to complete the attached scholarship application.

The participant must show proof of income (2017 income tax forms). Income maximum is \$52,398 annually. Extenuating circumstances will be considered.

10. Applicants will be considered based on financial need.

11. The parent or guardian must submit a written statement indicating why a scholarship is being sought, which will be kept strictly confidential.

12. If the participant wishes to attend any of the offered field trips, they will be responsible to pay for the cost associated with that field trip. The cost of field trips will not be paid for by scholarship.

13. If applicable, the participant must pay for a t-shirt for each weekly session that they attend when required.

14. Application deadline is two (2) weeks prior to start of program Session.

**You will now have to pay a percentage of the cost of the program either 25%, 50%, and 75%.**

### Income Guide Lines

**Level 1- 75% \$40,516- 52,398**

**Participant/Family will be responsible to pay 75% of the cost of the program for which they Registered**

**Level 2- 50% \$28,636-40,515**

**Participant/Family will be responsible to pay 50% of the cost of the program for which they Registered**

**Level 3- 25% \$16,755- 28,635**

**Participant/Family will be responsible to pay 25% of the cost of the program for which they Registered**

**\*\*Attendance is mandatory in order to maintain scholarship eligibility\*\***

## **\*New Information on Scholarships\***

There is now a limit on the number of programs that a child can participate in for a scholarship.

1 child per. Season. For example if you have 2 children they can participate in 1 program for that season.

The amount is up to \$150.00 that the scholarship can pay per family, per child.

The seasons are **Winter** and **Spring** and **Summer** and **Fall**. You will now have to pay a percentage of the program, either 25%, 50%, 75%.

**We offer Split payment option, which means this payment option can only be used for programs \$200.00 or more and are of multiple sessions-not one day events.**
